14 SDNPA - South Downs National Park Board councillor representative vacancy

Due to Councillor Meyer having moved out of the area, he is no longer eligible to sit on the SDNP Board. As a result, a vacancy has arisen for a councillor representative to sit on the Board. Any Town, Parish Council or Parish Meeting that is located wholly or partially within the National Park boundary is entitled to nominate a councillor representative.

There are six parish representatives [two from each of Hampshire, West Sussex and East Sussex] serving on the 26-person Board. Should they receive more than one nomination for this vacancy it will be necessary to hold a ballot and you will be notified should this be the case.

The first stage is to nominate a councillor. This part of the process will need to be completed by **February 15**th. Please note Christopher Baker Chairman of Iford Parish Meeting has asked to be considered (see papers).
