- 11 i Code of Conduct All references to "he/she" amended to "they" and "him/her" amended to "them"
- 11 ii Model Standing Orders NALC have updated Model Standing Order (England) 18 to comply with new procurement legislation and ensure consistency with the Model Financial Regulations. The changes are to 18.a.v, 18.c, 18.d, and 18.f. They've also updated Model Standing Order (England) 14 to better reflect Code of Conduct requirements. 14.a, 14.b, and 14.c have been removed. They have also changed the language in the document to gender-neutral terms to align with their policy and the Civility and Respect Project.
- 11 iii Financial Regulations Changes NALC have issued updated Model Financial Regulations to accommodate The Procurement Act 2023 and The Procurement Regulation 2024, which came into effect recently. ## Other general updates

- i. **Benches:** The bench at the junction of Springett Avenue and Harvard Road is scheduled to be repainted shortly. The bench has been installed in the bus shelter at Goldsborough Hall next to the Scout Hut.
- ii. **Emergency Plan update** AW is working on the draft document, and a meeting has been arranged for 20<sup>th</sup> May, with LG, AH, SP, GS and AW to review.
- iii. **A Provisional TPO** has been arranged for an Oak (Querus Robur) on the western edge of the entrance to a footpath on Broyle Lane, to protect the tree due to the potential development at Howell's Bank Farm.
- iv. **Year End Accounts** There are no changes required to the year-end accounts signed at the April meeting following the Internal Audit.
- v. Allotments: Composting Toilet UKPN have been chased for a response, still no reply. Feedback from other PC's using composting toilets on their allotments was positive. The average cost to supply and install appeared to be in the region of £12k for the lower maintenance units, which still need regular attendance for interior cleaning and topping-up toilet rolls etc. This seemed to be a task undertaken by those with an 'Allotment Holders Association'.
